0) Call meeting to order.

7:07 pm – Julie called the meeting to order and the minutes from the previous meeting were accepted.

1) Welcome and President’s Report
 Julie provided an update of TFIN.

To date TFIN has raised over \$3,031,000 with 55% of Stevens Creek families contributing. Teachers donated five furlough days raising \$1 million. Julie thanked and recognized PTO members who volunteered on the TFIN campaign.

The PTO Board passed a motion via online voting on May 11, 2010 to donate to the TFIN campaign \$1,000 (\$850 from miscellaneous, presidents’ discretionary and principal’s discretionary funds, plus \$150 remaining from the fund to promote the TFIN campaign).

Louise gave a summary of the Walkathon fundraiser which raised an estimated \$70,000 to date, almost two thousand dollars more than last year.

Louise provided an update of the Ice Cream Social and Open House.

Julie gave an update of Teacher Appreciation Week activities.

Julie informed the Board that the Giants game fundraiser has been cancelled because the cost of promoting the event would use up the funds raised.

The PTO Board held an Interim Board Meeting on May 5, 2010 in the Staff Lounge at 7:30 p.m. to discuss and vote on reinstating the half-hour for the Technology Aide position. Louise provided background on the vote, and that the motion had passed.

2) Principal's Report

Vivian thanked the community and PTO for supporting TFIN.

Vivian informed that there would be no charge this year for the ice cream at the Ice Cream Social and Open House.

Vivian also informed that the PTO does not have to pay for two Instructional Aide positions, a savings of \$34,000.

All decisions about next year's budget can be done only after the preliminary budget for 2010-2011 is determined.

3) Treasurers' Report

David handed out a chart of the cash balance and breakdown of the April 2010 actuals. A correction is noted in that the handout says 'March' but the data is for 'April'.

Income for the year is \$200,000, and cash balance is \$310,000.

Gia reported that the yearbook overage is \$543, not \$800.

Rick recommended that per the by-laws the overage amount should be voted on by the membership at the next PTO General meeting in June, with sufficient notification.

4) Roster update

Louise provided an update on PTO roster positions. There will be sign up sheets at the Ice Cream Social and the Walkathon, as well as a notice in the weekly newsletter.

5) Questions/Comments

The next meeting will be on June 3, 2010.
